In the morning while the obstacle course is being set up, drivers and industry members will be treated to a seminar covering such things as truck pumps, bobtail rollovers and leak checks. After lunch, the competition takes places which includes a multiple choice test on the basics of propane, demonstration of all the items involved in a pre-trip inspection in front of a DOT inspector, and a 7-part driving obstacle course.

An added treat is that a propane-powered police patrol car from the City of Beckley will be on hand to view. Once the competition is over, the top three point winners will be recognized and there will be door prizes for all drivers who participate. That evening, a social hour and dinner is scheduled to help everyone relax and review the day's

On the second day, members can participate in either a golf outing on the popular but traditional Cobb Course or try their hand in the kitchen by entering the Omelet Cook-off.

This winter positioned propane at the center of the national energy discussion, and policy makers are anxious to hear from industry members. Right now, Congress is considering several key issues that will have a dramatic effect on you and your business.

Join us in Washington, D.C., June 2-4, as we take our messages to Capitol Hill.

- Increase Pipeline Transparency | Require FERC to prohibit federally regulated pipelines from favoring their affiliates, and amend federal law to require propane pipelines to seek approval before services can be discontinued.
- Link Export Policies with Inventory Levels | Promote legislation that protects American consumers during fuel emergencies.
- Update DOT Emergency Thresholds | Require the Department of Transportation to lift highway weight limits and implement regional hours of service exemptions during a declared winter fuels emergency.
- Lift the PERC Restriction | Ensure the Department of Commerce lifts the restriction on the Propane Education and Research Council so that it can make sure consumers know how to plan properly for the winter.

# Senate Passes "Reliable Home Heating Act of 2014"

**NPGA** is pleased to report that on May 21, 2014, the United States Senate passed S.2086, the *Reliable Home Heating Act of 2014*, by unanimous consent. This bill was sponsored by Sen. John Thune and cosponsored by 8 other Senators from both parties.

The bill authorizes State Governors, during a state of emergency caused by a shortage of residential heating fuel, to extend relief from 49 CFR Parts 390 -399 for up to three sequential 30-day periods and the relief must be recognized by the Federal Motor Carrier Safety Administration. The bill covers propane, heating oil, and natural gas within the definition of residential heating fuel. Furthermore, the bill requires the Administrator of the Energy Information Administration, using data compiled from the Administration's Weekly Petroleum Status Reports, to notify the Governor of each State in a Petroleum Administration for Defense District if the inventory of residential heating fuel within such district has been below the most recent 5-year average for more than 3 consecutive weeks.

**Finally,** the bill requires the Department of Transportation within 12 months from enactment to submit to Congress a report on the impacts of safety from the extensions issued by Governors according to this Act. In conducting the study, the Secretary shall review, at a minimum, (1) the safety implications of extending exemptions; and (2) a review of the exemption process to ensure clarity and efficiency during emergencies.

**Sen. Thune's** staff reports they have already been in contact with their House counterparts and hope to move the bill the rest of the way through Congress soon .
